Registration Deadline: Any athlete wanting to participate in Volleyball must notify Glenn no later than **Monday, September 21st**.

All athletes begin September 14th; athletes are to appear based on the Flyers 2025 team rosters listed on page 3 & 4. Athletes wishing to join volleyball that are not listed on any of the rosters. Should appear at the 6:00 p. to 7:00 p.m. time slot. *Please be prepared to stay for the 7-8 p.m. practice session. As you may be a better fit for one of those teams.* We will let you know which team to join on Monday, September 28th.

Volleyball - Friday – November 13th – OKUN Fieldhouse, Shawnee, KS.

Key points to remember:

- 1) 1) The team pays for the \$15.00/athlete registration fee. This registration fee helps cover the cost of the tournament and includes all meals for the athletes on Friday.

Every athlete will be registered for the State Tournament unless the Team Director has been informed otherwise. After the State Registration call back date has passed, athletes not attending the tournament will be required to reimburse the team for the \$15.00 registration fee.

State registration call back deadline:

- 2) ***Participation Fee:*** A \$25.00 participation fee applies to volleyball. This fee can either be paid online utilizing the donate button on the Flyers website (www.acflyers.com) or you can bring your payment to practice. Do not mail a check Special Olympics Kansas in Mission Kansas. This policy is not intended to exclude any athlete from this activity because of their inability to pay. Please See Glenn for assistance or questions regarding this matter. I have worked out various payment plans for several athletes.

- 3) **Transportation:** In order to determine transportation needs for State in November. Please let Glenn know if you will be traveling with the team or with parents, grandparents, or staff.

The team will cover the cost of transporting the athletes to and from state volleyball if athletes are on riding with the team.

Weather Alert/Rain Plan:

All Cancelation Notices posted on our web site and Facebook. The decision to cancel practice due to the weather conditions is a judgment call. We will make every attempt to decide about practice cancelations by 5:00 p.m. on the day of practice. It is your responsibility to ensure we have accurate current contact information on file. Be sure to check your e-mail, or check the Web site, check the Air Capital Flyers Facebook page before heading to practice on days we have questionable weather. Individual text regarding cancelations will not be answered.

If any portion of Wichita (or all of Sedgwick County) is under any type of Severe Weather Warning at practice time, that practice will be canceled.
